I move to amend Bylaws and Policy Article XVI, Financial Management, Membership Numbers, Policy, page 56.1 by inserting a new Policy 11.

The new Policy 11 would read:

- 11. Membership numbers that were in use on Airstreams while participating in historically significant events may be designated as Heritage Numbers. Heritage Numbers shall be reserved from reassignment. Current members assigned a membership number that is designated as a Heritage Number may continue to use that number as long as they remain members in good standing.

I also move to designate the following 83 membership numbers as Heritage Numbers. These membership numbers were originally assigned to Helen Byam Schwamborn and Dale Schwamborn, Andy and Connie Charles, Art and Caroline Costello, and the participants of the 1959-60 Cape Town to Cairo and 1963-64 Around the World Caravans:
